Limitation of liability and indemnification:

The Member agrees to save and hold harmless and indemnify Osprey Shores Resort Inc., its directors, officers and employees (collectively, the “Resort”) from any and all claims brought against the Resort by the Member in connection with the services herein provided and to indemnify and hold harmless the Resort from any third party claims brought against the Resort arising from the Member’s use of the resort facilities, including the cost to the Resort of its reasonable legal expenses to defend itself in any such claim or action. The Member acknowledges that there are no other agreements concerning the subject matter herein and that any change or modification to this agreement must be in writing and executed by an authorized signatory of the Resort. The Member agrees that any claim or dispute arising from this agreement shall be governed by the exclusive jurisdiction of the courts of Nova Scotia and Canada, where applicable.

Privileges:

**Rules and Policy Statement
(the 'Statement')**

Whereas, I have made application to be a Member of Osprey Shores Golf Association,
Whereas, a condition of Membership is the compliance of Members with various rules and policies as set out in this Statement, as amended from time to time,

I herein agree to:

Courtesy and Speed of Play:

1. Comply with the instructions of the Marshalls and Course Staff.
2. Carry on my person my Membership Card and to present this to the Marshalls and Course Staff upon request.
3. Let faster parties play through when requested.
4. Limit party size to foursomes to encourage faster play.
5. Refrain from profane language and behaviors disturbing to other Members.
6. Refrain from excessive time spent retrieving lost balls.

Maintaining the quality of the course:

1. Replace divots at the tees and fairways.
2. Repair ball marks on the putting surface.
3. Refrain from driving a power or pull cart within 10 feet of the green, tee blocks and bunkers.
4. Keep the power carts to the cart paths where provided.
5. Rake the sand in the bunker after play as a courtesy to following players.
6. Dispense with litter in the containers provided.
7. Only use the toilet facilities provided.

Alcohol Consumption:

1. Abide by the terms and conditions as specified by the license awarded to the Resort by the Nova Scotia Alcohol and Gaming Authority.
2. Refrain from consumption of any alcoholic beverage not purchased from the Resort.
3. If driving a motorized vehicle on Resort property, will remain well within the sobriety limits specified by Provincial authorities.

Appropriate Dress and Deportment:

1. Wear clothing appropriate to the conditions and which is not offensive to other Members.
2. Conduct myself while at the Resort in a manner that enhances the reputation of the Membership, the Course and the Resort.
